



**DIRECTOR OF NURSING, ACTING DIRECTOR OF NURSING  
OR ADMINISTRATOR (WITH SUBLIMITS)**

In consideration of the premium paid, and subject to the Professional Liability limits of liability shown on the **CERTIFICATE OF INSURANCE**, it is agreed that the **PROFESSIONAL LIABILITY COVERAGE PART** is amended as follows:

- Item **A. PROFESSIONAL LIABILITY LIMITS OF LIABILITY** on the **CERTIFICATE OF INSURANCE** is amended to include the following schedule:

<b>Director of Nursing Claim, Each Claim Sublimit:</b>	<b>\$100,000</b>
<b>Director of Nursing Claim In the Aggregate Sublimit:</b>	<b>\$300,000</b>

- Solely for the purpose of the coverage provided by this endorsement, Section **IV. ADDITIONAL DEFINITIONS** is amended as follows:

**“Administrative Services”** means planning, organizing, directing, and controlling operations within the scope of duties of a director of nursing, acting director of nursing or administrator.

**“Administrative Services”** does not mean the provision of medical care or treatment of patients.

**“Director of Nursing Claim”** means a **claim** based on or arising out of **administrative services** provided by the **named insured** when acting in the capacity of a director of nursing, acting director of nursing or administrator.

**“You”** or **“Your”** means the **named insured**, provided the **named insured** is a natural person.

- Section **VI. LIMIT OF LIABILITY** is amended by the addition of the following:

Solely with respect to **director of nursing claims**, the following sublimits as stated in A. and B. below shall apply:

**A. Director of Nursing Claim Each Claim Sublimit**

Notwithstanding the limits of liability stated on the **CERTIFICATE OF INSURANCE**, the **director of nursing claim** each **claim** sublimit of liability shown in the schedule of this endorsement is the most we will pay for each **director of nursing claim**. The **director of nursing claim** each **claim** sublimit is part of, and not in addition to the limits of liability shown on the **CERTIFICATE OF INSURANCE**.

**B. Aggregate Director of Nursing, Acting Director of Nursing or Administrator Claim Limit**

Notwithstanding the limits of liability stated on the **CERTIFICATE OF INSURANCE** and subject to provision A. above, the **director of nursing claim** in the aggregate sublimit of liability shown in the schedule of this endorsement is the most we will pay for all **director of nursing claims**. The **director of nursing claim** in the aggregate sublimit of liability is part of, and not in addition to the limits of liability shown on the **CERTIFICATE OF INSURANCE**.



**C. Related Claims**

If **related claims** are made against **you**, all such **related claims** shall be considered a single **claim**, and the sub-limits of liability shown above shall be the limits of liability applicable to the policy period in force when the act, error or omission, or earliest of related acts, errors or omissions, occurred. The sub-limits of liability shown above, are the maximum amount we will pay regardless of the number of **claims** made or persons or entities making **claims**.

If more than one of this policy's coverages apply to the same **injury** or **damage**, we will not pay more than the limit of the Coverage Part most applicable to the type of **injury** or **damage** sustained, or the actual amount of the injury or damage, whichever is less.

All other terms and conditions of the Policy remain unchanged.

This endorsement, which forms a part of and is for attachment to the Policy issued by the designated Insurers, takes effect on the effective date of said Policy at the hour stated in said Policy and expires concurrently with said Policy unless another effective date is shown below.
